#### Trustees' Annual Report Year ended 31 December 2023

#### Structure, Governance and Management

#### **Governing Document**

The Church is administered in accordance with the terms of the Deed of Constitution (Unitary Form).

#### **Recruitment and Appointment of Trustees**

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The Minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery. Members of the congregation who are not elders and who are considered to have other appropriate gifts and skills can be elected to serve on the Executive or Committees.

#### **Organisational Structure**

The Kirk session, which meets four times a year, is responsible for the affairs spiritual and temporal within the congregation. Certain matters, outlined in the Constitution (Unitary Form), are delegated to the Executive.

#### **Objectives and Activities**

Skelmorlie and Wemyss Bay Parish Church is a constituent congregation of the Church of Scotland. The Church of Scotland is Trinitarian in doctrine, reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Congregational activities include: - Acts of Worship, Fellowship, Bible Study, Friendship Circle, Prayer Group, Social and Fundraising Events, Community Activities including Country Dancing.

#### **Future**

Skelmorlie and Wemyss Bay Parish Church is uniting with its linked congregation, Inverkip Church, on 1<sup>st</sup> January 2024 to create Inverkip, Wemyss Bay and Skelmorlie Church of Scotland. All assets, liabilities and activities of the Church will transfer to the united Church which will retain Inverkip's charity number, SC001079. Charity number SC003309 will be wound up as of 31<sup>st</sup> December 2023.

#### **Achievements and Performance**

2023 has been another quite challenging year, as Skelmorlie and Wemyss Bay Parish Church has continued without a Minister, due to the national Church continuing a moratorium on ministerial calls while Presbyteries complete their future planning process. Clyde Presbytery has finally confirmed its plan and on January 1<sup>st</sup> 2024, Skelmorlie and Wemyss Bay Parish Church will unite with our linked charge at Inverkip Church to form the united congregation of Inverkip, Skelmorlie and Wemyss Bay Church of Scotland with places of worship in both Inverkip and Skelmorlie. We will then be able to call a minister. This is a very positive outcome for our local churches compared with the situation facing many churches elsewhere.

We are indebted to our friend, Rev. Liz Geddes, Marion Stewart, Phil Theaker and the Worship Leaders from our linked congregation at Inverkip for conducting our Sunday worship so faithfully and meaningfully since 2021 when we have not had a Minister. We are also grateful to our Interim Moderator, the Rev. Karen Harbison for her support, guidance and encouragement. Our Pastoral Assistant, Lynsey Graham has also led worship and has become involved in many aspects of the work of the congregation as well as her core activity of providing pastoral support to those in need.

Our Audio-Visual team has ensured that we have continued to make our weekly services available for viewing online via YouTube, an innovation which was very positively received during the COVID restrictions. The Kirk Session has met regularly to conduct business and our usual activities such as the Friendship Circle, Bible Study, social and fundraising events, and country dancing have continued. Many events are now joint initiatives with Inverkip

Membership and income continue to reduce but not significantly, particularly when the future of the church has been in some doubt and we have been without a minister for quite some time. We thank our members for their sustained generous support financially. In particular, we thank those who have so willingly give of their time and talents in so many areas. Without these efforts, there would be no Church of Scotland in Skelmorlie and Wemyss Bay.

#### **Financial Review**

The 2023 accounts are prepared on a Receipts and Payments (cash) basis and show a deficit for the year of £2,434. This is not a major concern given the level of reserves held by the Church.

The principal source of income is member offerings and donations. Total offerings and donations for 2023 were £41,003 excluding Gift Aid tax refunded, down £5,583 or 12%, from 2022.

Other points worth noting are:

- Our 50% share of the cost of the Pastoral Assistant post which is shared with Inverkip Church and was previously part funded by Clyde Presbytery, was £6,472 for 2023.
- We received an insurance claim payment of £4380 in relation to accident damage to the boundary wall on Long Hill. Expenditure to repair this damage will be 2024.

#### **Reserves Policy**

At the year end the Church held unrestricted funds of £240,967 of which £50,640 is designated for the property maintenance fund and £884 for the Sunday Club. The remaining balance of £180,562 in the General Fund is available to meet any item of unexpected expenditure in the future. The Church also held £8,881 of restricted funds in the W L Kerr Organ Fund.

In addition the General Trustees of the Church of Scotland hold assets valued at £41,306 on behalf of the Church which is available to meet items of expenditure on the Church buildings.

#### Statement of Trustees' Responsibilities

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

Independent Examiner's Report to the Trustees of Skelmorlie & Wemyss Bay Parish Church I report on the accounts of the charity for the year ended 31 December 2023 which are set out on pages 7 to 11.

#### Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

#### Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.
