Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Deed of Constitution (Unitary Form).

Recruitment and Appointment of Trustees

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The Minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

Organisational Structure

The Kirk Session, which is chaired by the Interim Moderator, meets around six times in a year. It is responsible for the spiritual and material affairs within the church. Certain responsibilities are delegated to the following working groups; Property, Worship, Pastoral Care, Mission and Outreach, Finance and Eco-group as appropriate.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

There is a service of worship every Sunday morning at 10am in the church, with a crèche provided for the under 3s. Older children attend the first part of the service before leaving for the church halls for Sunday School. There are approximately 10 children in the Sunday School. We have informal services called Soul Searching on the second Thursday evening of the month and Cafe Church on the last Thursday evening of the month.

The Sacrament of Communion is celebrated four times a year on the first Sundays in February, June and October and Easter Sunday. Elders visit members in their districts with an invitation to Communion. We are pleased, however, to welcome all to these services.

The organist, shared with our linked congregation, plays at every Sunday service, with the praise band leading the worship at Baptismal services and other occasions during the year. Worship is shared with Skelmorlie and Wemyss Bay Church during Christmas and Holy Week, where we also join with St Joseph and St Patrick's Catholic Church at Wemyss Bay.

Inverkip Church has a number of groups meeting on a regular basis in the church hall; the Guild, Country Dancing and Badminton. There are also a number of community groups and clubs using the church halls each week.

A quarterly newsletter is produced, to keep people informed of all the activities and services in the church. Copies are distributed to all members, local shops, Community Hub, Skelmorlie and Wemyss Bay Church and copies are available in the church for visitors.

The church has a website and Facebook page which is updated regularly. Posters are produced for key services and events and are distributed at key locations around the village, including using the Community Council noticeboards, to increase awareness of church activities.

The Mission and Outreach group organise fundraising activities throughout the year. Other initiatives such as encouraging members and adherents to complete gift aid declarations and use 'amazonsmile' when shopping online are promoted to help maximise income.

Inverkip Church actively supports a number of charities and groups locally, nationally and internationally throughout the year. This is done both practically, for example the Christmas Gift Service where children's toys are donated to local children in need and distributed by the Salvation Army, donations of household items to Inverclyde Foodbank/Starter Packs and the Blythswood Shoebox appeal. Retiring offerings are held regularly for charities chosen by the Kirk Session at Harvest and Christmas and at other times during the year.

Links with the Primary School are thriving again with services held in the church throughout the year.

A Liaison Group is formed of Session Clerks and other Elders from each of the linked congregations with the aim of working closely together. The Worship Group plan services at key times of the year; Easter, Remembrance Sunday and Christmas. Expenditure relating to the linked charge, for example the Manse at Skelmorlie is discussed, and dealt with by the Treasurers in each congregation under the Terms of Linkage.

Reports from Working Groups:

Mission and Outreach

Warm spaces - we continued our Soup and a Blether on Mondays 12:00 - 13:30 and averaged 20 attendees at each of the 20 free sessions. The P7s from Inverkip Primary continued to attend along with a member of staff and they all enjoyed the chat with the older attendees.

Top team competition - we held our annual quiz in January with 8 teams from various organisations from Inverkip and Skelmorlie taking part. An enjoyable outreach event and won by the Country Dancers.

Folk Night & Variety Concert - This event was held in March and entertainment was provided by a wealth of local talent. Between 60-70 people enjoyed a wonderful evening, in particular the Ukrainian family who were staying with a local family. The Clydeside Singers performed a special song especially for them in Ukrainian.

Kip Fest - Inverkip Church once again formed a village partnership with Inverkip Community Hub to organise a weekend of events in June under the banner of Kip Fest with something for all ages. With the help of Inverkip Bowling Club, Inverkip Hotel, Inverkip Scouts and Cubs, Inverkip Primary and donations from Inverclyde Council and local businesses, it was a terrific weekend with entertainment for the whole community.

Silent Disco - A fun event in November for all children up to Secondary age. There were 2 sessions arranged for up to Primary 6 and then Primary 7 and Secondary. We had approximately 40 children for the younger age group who had great fun jumping around with headsets on and listening to their choice of music. There was also a tuck shop run by a member's daughter who was fundraising for her trip to America in 2024 to represent Scotland in the Cheerleaders World Championships. There were no attendees for the older age group so perhaps not an event for them.

Advent - once again goody bags were distributed to the elderly in the Parish containing homemade Christmas cake, shortbread, candle, Christmas tree decoration made by Sunday school, quizzes and a letter from Karen Harbison, our Interim Moderator.

Another successful Light Night was held outside of the church on 3 December with Christmas lights on the trees and bushes and hot drinks on offer. Everyone could write a message on the wooden disc provided and light a candle in remembrance of someone. The discs of remembrance were then hung on the Eco Christmas Tree which was decorated with fat balls and peanut and cranberry garlands. The church was open for quiet contemplation and toys for distribution by the Salvation Army could be left inside. The event was attended by lots of members of the church and community.

Foodbank & starter packs collection - these continued monthly and were really well supported by the local community, as well as the congregation.

Parish Christmas card - The children of Inverkip Primary School once again had a competition to design the Christmas card and winning designs were excellent. These were then printed and distributed to all homes in the village and outlying areas, 1,700 in total. Inside the cards was a list of all the services in Advent how to access the online services, plus a list of activities scheduled for December, including a Nativity Play, toy collection for the Salvation Army and Light Night.

CrossReach - we once again took orders for CrossReach cards and calendars which was well supported.

Welcome Packs - continued to be distributed again to new people moving into the area. They consist of the Church Welcome leaflet, a candle or plant and a bar of fairtrade chocolate. We rely on people letting us know when they have new neighbours.

Property

As most readers will know, the Church of Scotland continued its property disinvestment exercise during 2023 by reviewing sanctuary buildings and church halls. Significant capital expenditure was not to be undertaken until the outcomes were finalised, unless absolutely necessary. Our church roof justified exemption and we thus had the lead course renewed and a sizeable repair effected. This entailed a series of bat surveys (the attic famously being the summer roost of around one thousand soprano pipistrelle bats) followed by two phases involving scaffolding for our regular roofer to access the entire perimeter of the roof during late spring and mid-autumn.

The manse was not included in the property review and thus we replaced a large picture window in the main living room, together with the front door.

The lights in the Crawford Hall were all replaced by more eco-friendly bulbs following some accidental damage.

The internal doors of the Church Halls were repainted, along with some other "touch up" painting jobs. In the Grounds, a bund was introduced to the driveway to contain the stone chips as much as possible, and the seating area was slabbed with the same intent.

Maintenance tasks were performed throughout the year, including the servicing of boilers, fire-fighting resources and the audio-visual equipment. Gutters and drains were regularly cleared. Gardening tasks took up much of the spring and summer months. Minor repairs were also effected, such as replacing the back panel of the external noticeboard and fixing faulty outside lights.

In short, although 2023 was a relatively quiet year by Property Group standards everyone involved was productively employed and continued to enjoy the camaraderie that shared activity generates.

My sincere thanks go to all members and those who help them. As always, we would warmly welcome new volunteers

We try to vary the style of worship and often use skits and scripts to illustrate points.

Coupled with delicious home baking and great singing usually accompanied by organ and guitar our evenings are enjoyed by all who manage along.

Guild

We have thirteen members and currently meet once a month in the Bonomy Room of the church hall. As we are a small group we try to find speaker locally. As we are part of Guilds Together we go to other meetings and this Christmas we held the Guilds Together meeting. We had 42 members attending.

Last year we held the World Day of Prayer here and this year it will be one of our neighbouring churches. We have three churches who host it in turns.

Last year we held a silent auction which gave us the finances to send £100 each to both Beat and Vine Trust - two of our projects. We also sent £50 for trees for the Green Canopy appeal. We also donated £200 to the Church. At Christmas we held a special recital offering at the church which raised £177 for the Waterfront Campus , Erskine, - a Crossreach project. Although small in number, we enjoy fellowship with the other Guilds and welcome others to come to our meetings.

Country Dancing

We hold our Country Dancing on a Thursday Night in the Church Hall. At present we have 14 members with an average attendance of 10 to 12. We charge £10 per term and 20 pence for tea and coffee. Last year we bought new tea and coffee pots to replace the old ones. With the remainder of last year's money plus this session we were able to donate £350 towards a dishwasher for the kitchen.

We go to dance at other classes and invite them to come to us for special party nights. We are currently the holders of the Top Team competition held in the Church and will be defending our place this year.

Country Dancing is good for both mind and soul. New members are always welcome.

Badminton

The Club played more or less for whole of 2023, meeting on a Monday evening at 19:45 in the church hall. Some new members joined us and there was a variety of abilities. It was good to welcome some teenagers who seem to be very keen and, in particular one member of the local Ukrainian family. New members of all abilities are always welcome, 15 years and over.

Eco-group

The litter picking group, now named LitterKippers, has continued to meet once a month to tackle the many litter issues which our community faces. There is general littering around the village and beaches, marine litter washed up on the shoreline and fly tipping. Over the past year, the group collected a total of 178 bin bags of litter from around our community, 65 of which were sorted for recycling, and doesn't include all the larger fly tipped items unable to be bagged. This is down again from the previous year and is probably down to a couple of factors. The number of volunteers has dropped significantly, often there are only 8-10 regulars, but also a lot of the "historical" litter has now been cleared from around the community. The wet summer, and also concerted effort from various agencies such as Police, community wardens also meant that there was less littering from parties down at the beach and shore path. We are delighted to work in conjunction with our young folk, and our picks have been bolstered by the Scouts and Cubs, their leaders and parents of the 85th Greenock & District Scout Group, who have helped out at a few litter picks over the course of the year, and with more planned in the year to come.

In March we took part in the Spring Clean Scotland campaign with Keep Scotland Beautiful, and will be part of the campaign this coming spring too.

Our thanks go to all the volunteers who have turned out in all weathers to help to make a difference to our community and local environment, and to staff from Inverclyde Council for the provision of litter picking equipment, bags and for the collection of the rubbish afterwards. The group continues to liaise with, support and be supported by the other litter picking groups in Inverclyde under the umbrella of Literati Guide to Inverclyde. Our newspaper and magazine collection has continued throughout the year, and delivered regularly to White House Products in Port Glasgow, who shred them and use to package their products. A small donation is made per kilo, and over the past year, the accumulated total was 1883.5kg (nearly 2 metric tonnes!) with a projected donation of £188.35 which will be used to

replace litter picking equipment.

The church continues to have monthly collections for Inverciyde Foodbank and Starter Packs Inverciyde. Empty medication packs can also be dropped off and these are then taken to a local collection point for recycling.

Over the past year the group continues to promote local fair trade events and global issues through social media. It is hoped that a monthly fair trade stall will be able to resume in the coming months. The Eco group will also use this opportunity again to offer refills of eco friendly washing up liquid, previously popular with many members. Refills and many other eco and plastic free products can be purchased at local shop Invereco, in Greenock and members are encouraged to give this great wee business our support.

Our thanks go to all those who continue to support our eco initiatives, and we look forward to being able to continue and develop over the year to come.

Sunday School

The Sunday School meets at Inverkip Halls on Sunday mornings during the 10am service. This year Sarah Graham did her PVG and Safe Guarding Training and has been coming to help out. We had another successful Nativity play and Christmas Eve Family Service and have been working on crafts and learning new songs as per the children's request. We painted stones to put on the beach for people to find and made stained glass windows. We hope to go on a trip soon to visit the Skelmorlie church campus and are looking into some bibles or other keepsakes for the children to be presented with in order to mark the Union of the two churches in 2024.

Café Church

Café Church continues to meet on the last Thursday of the month in the Wemyss Bay Station café. We have a regular crowd and this is made up of both church goers and non church goers. We have guest speakers, praise music, a resident poet and much more. We now have a promotional video which is available to be viewed on the Church of Scotland's YouTube channel and have made lots of connections since this video was posted from other churches hoping to do a similar thing.

Pastoral Care

We have six members in the team at the moment which is four less than when it started. The team is here to assist the minister and pastoral assistant such that when information is received of people who are sick or in hospital, the minister and the elder of that district are informed. Thanks to all the elders who have assisted us.

The minister or pastoral assistant normally make the first visit to those who are in hospital or at home and if required will pass information on to the team to arrange further visits. It is good that people within the community are letting us know of people who are sick or in The group are also available to run people to hospital or doctor's appointments and to church on a Sunday.

Reserves Policy

It is the Trustees' policy to cover General Fund expenditure and transfer any surplus funds to the Fabric Fund. At the end of the year the congregation held Unrestricted cash funds of £78,421 (2022: £68,338).

This balance is considered adequate to meet the ongoing General Fund requirements.

The Church held £25,243 (2022: £19,683) of restricted funds which have been provided for the purposes specified in Note 10.

The Church also held £33,945 (2022: £34,084) of Endowment Funds which have been provided for the purposes specified in Note 9.

Statement of Trustees' Responsibilities

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

The total income for 2023 was £71,409. Offerings at £53,457 (2022: £46,461) form the largest source of voluntary income. These are detailed below:

Throughout the year, the Treasurer has claimed on the consolidated fabric fund from the Church of Scotland, in relation to the income from the tenants in the Inverkip Manse however, the Manse is currently vacant.

The total expenditure for 2023 was £66,744 (2022: £50,083).

The largest expense is Giving to Grow, an allocation by the Church of Scotland. In 2023 the net amount paid was £16,526 (2021: £17,388) (25% of our total expenditure). It is used by the Church of Scotland to fund ministry work both in Scotland and abroad. We have received notification that the figure for 2024 will be £3,578 per month for the united congregation.

Appendix 2 gives an overview of the income and expenditure of the Sunday School. Other church organisations, eg Country Dancing, Guild and Badminton are not included as they are self-sufficient.

Independent Examiner's Report to the Trustees of Inverkip Church

I report on the accounts of the charity for the year ended 31st December 2023 which are set out on pages 14 to 18.

Respective responsibilities of trustees and examiner
